**GRAYS HARBOR COUNTY REGION
SURFACE TRANSPORTATION PROGRAM (STP)
APPROVAL FOR FUNDING**

WHEREAS, the Grays Harbor Council of Governments (GHCOG) legally serves as the Lead Agency and Funding Authority for the Grays Harbor County Region Surface Transportation Program (STP) process; and,

WHEREAS, the 2019, 2020, 2021 regional funding round under the Fixing America's Surface Transportation Act or "FAST Act" consists of \$3,095,848 which is the Estimated Surface Transportation Program (STP) Allocation for the region, and;

WHEREAS, the agencies accepting funding have agreed to abide by the Surface Transportation Program (STP) Policies and Procedures approved on 12/14/2017 by resolution No. 621, including timely obligation, and;

WHEREAS, agencies accepting STP funds will receive written notification of the funding approval within 30 days of the award provided that all required paperwork has been returned with signatures to GHCOG, abiding by STP Policies and Procedures and;

WHEREAS, the Grays Harbor County Region STP Technical Advisory Committee has reviewed the projects according to due process and recommends the following project list for Policy Board consideration, and;

WHEREAS, the results of the TAC funding request are as follows:
