# Administrative Sub-Council Report

Executive Director, Vicki Cummings, reported a Sub-Council meeting was held. The election of officers and meeting agenda were discussed. The February bills and payroll were reviewed. A note was made of the significant increase in the bills this month's total due to a multi-month invoice for \$88,653.53 from Montrose, the EPA Brownfield consultant. No other action was taken.

# > ACTION: 2025 Administrative Sub-Council Election of Officers

# > ACTION: Approval of Resolution #692 GHCOG 2025 Budget, Amendment #1

The 2025 budget was amended to roll back the 2025 Member Dues to the 2024 rates since the member letters were tardy being sent out. Vicki asked that the board disregard a miscellaneous page attached to the supporting documents as it was unintentionally included with the packet this month.

#### > ACTION: Approval of Resolution #693 2025 Cost Allocation Plan

Because GHCOG receives federal transportation funding for the Surface Transportation Program we are required to develop and adopt an annual Cost Allocation Plan. The 2025 Cost Allocation Plan was reconciled and the 2024 budget was input to determine the new 2025 Cost Allocation rates for benefits and salaries.

Linda Springer made a motion to approve; second, Brandon Pauley. Motion passed unanimously.

#### DISCUSSION: 2025 Meeting Calendar

Troy Meyers presented the calendar and asked the board about a scheduling conflict for the June meeting, asking if the board would like to reschedule, cancel or revisit the decision again in May. Troy explained to the board that, if necessary, the claims and other monthly items could be handled in a Sub-Council meeting if the board chose to cancel the full meeting in June. The board chose to revisit the schedule in May to decide.

#### 7. MEMBER/PUBLIC COMMENT

- City of Cosmopolis, Mayor Linda Springer
  - Met with Cyndi Klinger senior engineer for project management on the stormwater and Mill Greek objective plan.
  - Received email from Brian Shay that the RCO allocated some additional funds for Cosmopolis.
  - Fully staffed in the Public Works Department.
  - The City Council approved the CPA, Tara Dunford, for another year.
  - The administration will be moving into the new City Hall building at the end of March and are currently looking for inexpensive furniture. Will be having an open house.
  - The \$100,000 RCO grant for Mill Creek restoration is on track to meet all objectives in June.
  - Received a \$5,000 grant for the Grays Harbor Community Foundation for new basketball hoops.

#### City of Elma, Mayor Josh Collette

- Meeting on Monday, February 24<sup>th</sup> to award the bid for the remodel of the old mortuary building into the new police department and court, to Christiansen Inc. Total budget for the project is \$1.7 million, with \$1.4 million covered by grants. (Court Security grant and USDA Direct Appropriation grant through Rep. Derek Kilmer.)
- Anticipate approving Parks and Open Space Plan in March with S.C.J. Alliance through and RCO grant.

#### City of Hoquiam, Councilmember Brandon Pauley

• The City Council voted to contribute \$10,000 or 1/6<sup>th</sup> of the funding to the Rail Study that Aberdeen is leading.

#### City of McCleary, Mayor Chris Miller

- The city has gone out for design RFP for the lower 3<sup>rd</sup> street project.
- Construction will begin this summer for the grant funded sidewalk project.
- Working to finalize the bidding for the chipseal project, scheduled to start this summer.
- Working with the state legislature for park funding.

### City of Ocean Shores, Councilmember Rich Hartman

- Army Corp of Engineers Update on the North Jetty Reconstruction project Contracts will go out in August, projected to start in 2026 and completion in 2027.
- Teamed up with Westport for FEMA's for 2025 CTP (Cooperative Technical Partners) program on Comprehensive Coastal Erosion Strategy. Have received some Commerce grants to help with erosion.

## City of Westport, Councilmember Troy Meyers

- Working with the Department of Ecology for clarity and consistency on the shoreline management plan.
- Onboarded Tommy Cappa as a new City Administrator. Formerly worked with the Shoalwater Tribe as their business manager.
- Moving ahead on Skate Park and Pump Track project.
- HB-1806 Championed by Rep. Tharinger, Bill should help bring landing tax back to port cities to help deal with wear and tear on infrastructure. \$180 million pounds of seafood leaves Westport annually.
- The Police Chief is looking to fill two officer vacancies and is accepting lateral transfers.
- Frank Eshpeter attended the Port of Grays Harbor's Annual Business meeting and stated it was very well attended and informative.

# Grays Harbor Transit, General Manager Ken Mehin

• New software implemented starting March 1<sup>st</sup> to allow customers to schedule their own Dial-a-Ride, available on mobile devices and updates the driver's schedule in real-time.

### Timberland Regional Library, Elma Library Manager Dee Depoe

• LinkedIn Learning is free to Library members and topics cover a wide variety of topics. This is a service you would normally pay for if you were not a Library member.

# Grays Harbor County, Commissioner Rick Hole

• Cooperative Technical Partners grant from FEMA for \$150,000 to expand and study the scope, step one in the on Comprehensive Coastal Erosion Strategy plan.
