 - Grays Harbor Transit Board retreat very well done

- City of Hoquiam, Mayor Ben Winkelman
 - Police Chief retiring end of June
 - Executive Secretary position open in the Mayor's office
 - Joined with Mayor Martin (Ocean Shores) in National Move With the Mayor program. Only two Mayors in the state to join. Will receive funding for activities and events.
 - City Council approved motion to change Beacon Hill Park from tennis courts to pickle ball courts. Working with Library to allow residents to check out pickle ball kits.

 - The reservation is now open, first time since Covid started
 - Received funding for 88 corners
 - Received funding to put in engineered log jams for Blueback Salmon habitat restoration
 - Seeking funding for Ocean Fiber project
 - Holding meetings in person now
 - Serving seniors/Elders lunches in the new Generations building for first time this Monday

- Held General Council position for 9 years. General Council elections are next month

 - Authorized contracts for management services and construction for the roundabout
 - Authorized MOU for fire and emergency medical services with Cosmopolis

 - US 12 - SR 8 - Grays Harbor County Fish Passage Barriers - Remove Fish Barriers:
Crews are collecting pavement samples or working with local utility crews for utility relocation this week and next during daytime hours in advance of future projects.  - US 101 - SR 109 Grays Harbor, Jefferson and Clallam Counties - Remove Fish Barriers:
Crews are collecting pavement samples or working with local utility crews for utility relocation this week and next during daytime hours in advance of future projects.  - US 101/Hoquiam River-Riverside Ave Bridge - Machine Rooms Rehab:
We are in the process of selecting a contractor. This project replaces and repairs two machine rooms that help operate the Bridge. Work includes repairs to the existing machine rooms and wall systems, removing the old machine room, and painting the operating room. To do this important preservation work, a large crane will lift materials, including new walls and a roofing system to the machine rooms on top of the bridge. Due to the nature of the work, crews will fully close the bridge for up to 8 full nights with a signed detour in place to do most of the work. - This month, two of our Aberdeen maintenance workers identified a rail washout along US 12 between Elma and Oakville, contacted the rail company and successfully stopped an oncoming locative.
